## RECREATION FACILITIES RULES AND POLICIES

### PAVILION OPEN

Year Round

### PAVILION RULES

1. **USE AT YOUR OWN RISK.**
2. **CHILDREN UNDER 16 YEARS** of age **MUST** be accompanied by an **ADULT MEMBER (18 years or older)**. Children 16 and older are allowed to supervise their own siblings age 12 and older.
3. The pavilion is available for rent. Availability is on a first come, first served basis, for a maximum of four (4) hours per rental. The fee for renting the pavilion is \$25.00 per four (4) hour use, with a \$75.00 deposit required. These must be in the form of two (2) checks. You will be required to have a recreation card to access the lights, fans and any tables you may need.
4. **NO:**
  - \* Running or Rough Play in the Pavilion Area
  - \* Alcoholic Beverages
  - \* Pets in the Pavilion Enclosure
  - \* Loud Music, Profanity, or any other activity that may be considered a nuisance around the Pavilion/Pool Area
  - \* No Skateboarding, bicycling, or motorized vehicles may be in or on the pavilion/park or pond area.
5. **DO NOT** leave children unattended at **ANY** time. Accidents can happen very quickly.
6. **ONLY MEMBERS** and their allotted guests are allowed in the Pavilion Area. **MEMBERS** are defined as **PROPERTY OWNERS** and their legal dependents.
7. **MEMBERS** must be current on Maintenance Fees.
8. **PICTURE ID CARD MUST BE PRESENTED UPON REQUEST**; failure to comply will result in disciplinary action and you may be asked to leave the premises. (Valid Texas Driver's License is allowed).
9. **VANDALISM** done by property owner, dependents, or guests will be billed to the **PROPERTY OWNER**.
10. **TRASH** must be removed before leaving the pavilion area. Please leave the area in the same condition you arrived to.
11. **FAILURE** to comply with the preceding rules will result in **IMMEDIATE DISCIPLINARY ACTION**.
12. **REPORT** all structural or mechanical problems to Magnolia Property Management.
13. **DISCIPLINARY ACTION - IF THERE ARE ANY VIOLATIONS AGAINST THE POOL, PARK PAVILION AND/OR POND RULES, THE CARD MAY BE REVOKED AT ANY TIME AND SUBJECT TO A \$50.00 PER CARD REACTIVATION FEE AFTER THE SUSPENSION PERIOD OF PRIVILEGES HAS PASSED.**

**PARK OPEN – 9 AM – 9 PM YEAR ROUND**  
**PARK RULES**

1. Intoxicated individuals under the influence of alcohol or drugs are prohibited from being anywhere on the park grounds.
2. **NO** alcoholic beverages allowed in the park.
3. **NO** hunting or shooting of **ANY** KIND is allowed in the park.
4. **NO** fireworks without written permission.
5. Open fires prohibited except as approved by the Board of Directors.
6. **NO** glass containers or items that could be a safety hazard
7. Parties must be approved by the Board of Directors.
8. **NO** loud music or other activities considered a nuisance
9. **NO** pets unless on a leash.
10. **NO** horses, cows or other livestock allowed in the park.
11. **NO** motorized vehicles allowed in the park except on the driveway and the paved parking lot.
12. **NO** overnight camping
13. **NO** swimming or boats in the lake, **INCLUDING PETS.**
14. **NO** littering ... please use the trash containers provided.
15. **PLEASE...**use appropriate language and behavior around your neighbors and children.
16. **FAILURE** to comply with the preceding rules will results in DISCIPLINARY ACTION.
17. **DISCIPLINARY ACTION - IF THERE ARE ANY VIOLATIONS AGAINST THE POOL, PARK PAVILION AND/OR POND RULES, THE CARD MAY BE REVOKED AT ANY TIME AND SUBJECT TO A \$50.00 PER CARD REACTIVATION FEE AFTER THE SUSPENSION PERIOD OF PRIVILEGES HAS PASSED.**

# POOL CLOSED

## WEDNESDAY (MAINTENANCE DAY)

1. SWIM AT YOUR OWN RISK. NO LIFEGUARD: NO SWIMMING ALONE and NO DIVING.
2. CHILDREN UNDER 16 YEARS of age MUST be accompanied by an ADULT MEMBER (18 years or older). **ALL CHILDREN MUST BE SUPERVISED AT ALL TIMES!**
3. NO SWIMMING BEFORE OR AFTER DESIGNATED HOURS.
4. Individuals under the influence of ALCOHOL OR DRUGS are PROHIBITED from being in the pool or pool area.
5. NO:
  - Running or Rough Play in the Pool Area
  - Alcoholic Beverages
  - Food, snacks, gum or candy in the Pool Area
  - Glass Containers
  - Smoking or Tobacco Products in Pool Area
  - Water Guns of ANY type
  - Large water toys (ONE (1) person raft/floats are allowed)
  - Clothing or shoes on the cement area around the pool
  - Cutoffs
  - Pets in the Pool Enclosure
  - Loud Music, Profanity, or any other activity that may be considered a nuisance around the Pool Area
6. NO POOL PARTIES.
7. DO NOT leave children unattended at ANY time. Accidents can happen very quickly.
8. Use shower before entering pool.
9. ONLY MEMBERS and their allotted guests are allowed in the Pool Area. MEMBERS are defined as PROPERTY OWNERS and their legal dependents.
10. MEMBERS must be current on Maintenance Fees, Fines and/or Attorney fees MUST be made before April 30 to have access to the pool. A VALID recreation card must be used to gain access to the pool area at all times.
11. ALL members of the household (college students included) living at home (same address) as the homeowner MUST be listed on the pool application. ONLY those 16 and older can access the pool without an adult.

12. EACH ADULT MEMBER (18 or older) IS LIMITED TO TWO (2) GUESTS in the pool AT ANY GIVEN TIME.
13. EACH DEPENDENT MEMBER IS LIMITED TO ONE (1) GUEST in the pool AT ANY GIVEN TIME.
14. Each household is limited to twelve (12) people (members and guests) at any one time.
15. PICTURE ID CARD MUST BE PRESENTED UPON REQUEST; failure to comply will result in disciplinary action (valid Texas Driver's License is allowed).
16. VANDALISM done by the property owner, dependents, or guests will be billed to the PROPERTY OWNER.
17. LIFESAVING EQUIPMENT IS FOR EMERGENCY USE ONLY. Misuse will result in Disciplinary Action.
18. The EXTERIOR MAIN ACCESS GATE is not to be propped open at any time.
19. Recreation Access Cards are to be used to enter and exit the pool area. DO NOT use the emergency exit button as a general exit/entrance tool.
20. DO NOT loan your Recreation Access Card to anyone. You are responsible for the use of the card and anyone that you allow into the pool area.
21. FAILURE to comply with the preceding rules will results in DISCIPLINARY ACTION.
22. DISCIPLINARY ACTION - IF THERE ARE ANY VIOLATIONS AGAINST THE POOL, PARK PAVILION AND/OR POND RULES, THE CARD MAY BE REVOKED AT ANY TIME AND SUBJECT TO A \$50.00 PER CARD REACTIVATION FEE AFTER THE SUSPENSION PERIOD OF PRIVILEGES HAS PASSED.
