RESOLUTION OF THE BOARD OF DIRECTORS OF

KATY CREEK RANCH HOMEOWNERS ASSOCIATION

Pursuant to Article IX, Section 3, of the Declaration of Covenants, Conditions and Restrictions for Katy Creek Ranch Homeowners Association recorded in the Real Property Records of Fort Bend County (hereinafter the "Declaration"), the Board of Directors (hereinafter the "Board") of the Association of Katy Creek Ranch Homeowners Association (hereinafter the "Association") is vested with the authority to impose reasonable fines against the Owners (as that term is defined in the Declaration), for violations of restrictive covenants contained in the Dedicatory Instruments (as that term is defined in the Texas Property Code) for Katy Creek Ranch Homeowners Association.

Upon violation of any of the Katy Creek Ranch Dedicatory Instruments, the Board may give the violating Owner written notice describing the violation and the amount of fine to be imposed, if any. The Board shall give the Owner a reasonable period of time to cure the violation and avoid the fine, unless the Owner has been given written notice and opportunity to cure a similar violation within the previous six months.

The Board shall inform the Owner that the Owner may request in writing a hearing before the Board, or designated, on or before the 30th day after the date the Owner receives the notice. The Board shall advise the Owner that if the hearing is held before a designated committee, that the Owner will have a right to appeal the decision of that committee to the Board upon written notice to the Board.

If a hearing is requested by the Owner, the Board shall hold a hearing within 30 days from the date of the receipt of the Owner's request for a hearing. The Board will notify the owner of the date, time and place of the hearing not later than the 10th day before the hearing. If a postponement of the hearing is requested by either the Board or the Owner, such postponement must be granted for a period of not more than 10 days. Any additional postponements may be granted by agreement of the parties. After an affirmative decision by the Board, or after the expiration of the written notice, the Association, through the Board, is hereby authorized to impose fines according to the following schedule for violations of any provisions of the Katy Creek Ranch Dedicatory Instruments:

FINES FOR VIOLATIONS OF THE ASSOCIATION'S DEDICATORY INSTRUMENTS

AFFECTING THE USE AND ENJOYMENT OF UNIT OWNERS

For violations of the Katy Creek Ranch Dedicatory Instruments affecting the use and enjoyment of Owners, the Board of Directors may reasonably set the amount of the fine as it reasonably relates to the violation of the dedicatory instruments and the number of Owners affected by the violation.

BE IT FURTHER RESOLVED: The Katy Creek Ranch Homeowners Association through its Board of Directors is hereby authorized to impose lesser fines or no fine at all for violations of the Bylaws, Rules and Regulations, Covenants, Conditions and Restrictions, or other Dedicatory Instruments of the Association as determined by the Board of Directors in its sole and absolute discretion.
