## **POOL RULES AND POLICIES**

## **Pool Hours:**

# Pool closed each Monday for maintenance. Tuesday-Sunday 10:00 am - 8:00 pm

### **Definitions:**

### MEMBERS

• Property owners and their legal dependents.

• Must be current on Maintenance Fees, Fines and/or Attorney fees before renewing

or issuing a Recreation Card.

• All members of the household wanting to utilize the recreation card must be listed

on the pool application.

• Each Adult Member (18 or older) is allowed two (2) guests in the pool at any given

time.

• Each Dependent Member is allowed one (1) Guest in the pool at any given time.

### DISCIPLINARY ACTION

• If there are any violations against the pool, park pavilion and/or pond rules, your card may be revoked at any time and subject to a \$50.00, per card, reactivation fee after the suspension period of privileges has passed.

1. NO LIFEGUARD: swim at your own risk, no swimming alone and no diving.

2. Children under 16 years of age must be accompanied by an adult member (18 years or older). All children must always be supervised!

3. No swimming before or after designated hours.

4. Individuals under the influence of alcohol or drugs are prohibited from being in the pool or pool area.

#### 5. The following actions are prohibited in the Pool Area:

- Running or rough play
- Alcoholic Beverages
- Food, snacks, gum or candy
- Glass Containers
- Smoking or tobacco products
- Water guns of any type
- Large water toys (one (1) person raft/floats are allowed)
- Clothing or shoes on the cement area around the pool
- Cutoffs
- Pets in the Pool Enclosure

• Loud music, profanity, or any other activity that may be considered a nuisance

- Open cups, pitchers, jugs, travel mugs, etc.
- 6. No pool parties unless written approval has been obtained.
- 7. Do not leave children unattended.
- 8. Use shower before entering pool.

9. Picture ID card (valid Texas Driver's License is allowed) must be presented upon request of any member; failure to comply will result in disciplinary action.

10. Vandalism by the property owner, dependents, or guests will be billed to the property owner.

11. Lifesaving equipment is for emergency use only. The equipment is located on the fence by the pool enclosure. Misuse will result in Disciplinary Action.

12. DO NOT prop open the exterior main access gate at any time.

13. Recreation Access Cards are to be used to enter and exit the pool area.

14. Do not loan your recreation card to anyone. You are responsible for the use of the card and anyone that you allow into the area.

15. In the event the pool phones are vandalized or becomes inoperable, the pool will be closed until the phones are in working order.

16. Bottled waters such as: Ozarka, Fiji, Nestle, Aquafina, etc., are the only beverage allowed at the pool. Personal containers such as travel mugs, pitchers, open cups and aluminum bottles regardless of content are not allowed at any time.

17. Failure to comply with the preceding rules will result in disciplinary action.

18. Please report all structural or mechanical problems to Magnolia Property Management at 281-599-0098.
